In order to continue classes without disruption of teaching the tenure of appointment made on guest basis was extended from 11th November to 15th November, 2019 under special circumstances. It should not be quoted as precedence in future.

Note: National Commission for Backward Classes directed us vide its letter no. NCBC/06/10/116/2019 dated 07.11.2019 (Copy enclosed).

9. Approved demand note letter received from TPDDL for installation of electricity meter in staff quarters amounting Rs.9,49,171/- (with GST) in Satyawati College. It was decided that amount be paid from the Development Fund and same may be adjusted as and when grant is received from UGC for staff quarters.

It was also resolved that a separate meter be installed till proper meter is installed by TPDDL and the Committee is constituted comprising of following members to decide tentative charge of electricity in staff quarters and requested to submit its report within 15 days:

- 10. Noted the letter no. CS-III/149/SC/2019/871 Dated 08.11.2019 received from university of Delhi regarding appointment of Mr. Vipin Bajpai, Security Guard and others and it was resolved to defer the matter.

It was resolved that notice be sent to all the Permanent Non-Teaching Staff residing in the Jhuggis to vacate the Jhuggis within two months from the date of receipt of notice, failing which, strict action would be taken as per rule.

It was also resolved that notice be sent to all the contractual staff residing in the Jhuggis to vacate the Jhuggis latest by 31st January, 2020, failing which, their services will be terminated.

- 12. It reconstituted the Building Committee of the College as per the UGC Norms.
 - 1. The Principal/In-Charge Principal (both colleges Morning and Evening)
 - 2. The Vice-Principal (if appointed)
 - 3. A representative of the affiliating University
 - 4. A technical representative of the CPWD/PWD/Zilla Parishad/Corporation, etc. (not below the rank of Assistant Engineer)
 - 5. Two representatives from the teachers of the college Senior Most Associate Professor and Senior Most Assistant Professor
 - 6. A representative from user-teaching department (s)
 - 7. A representative each from Administration and Accounts Division Each from Day and Evening
 - 8. The Architect engaged by the College. The person should be registered with the Council of Architecture

The quorum should be maintained while conducting meetings. The quorum is 1/3. However, the presence of University representative and either the Engineer or the Architect is must during the Building Committee meetings.

- 13. Noted the letter from Satyawati College morning to Satyawati College Evening regarding 50% Share of Water and 2/3 Share of Electricity Bill and Solar PV Project for timely payment. It was resolved that payment will be made by the Evening College within a week time after receipt of bill from the Day College.
- 14. It deferred IQAC report for next meeting of Governing Body.
- 15. To report final notice to be sent to R.L. Meena and explanation be asked from him as to why his services should not be terminated.
- 16. Noted the minutes of the committee formed by the Governing Body regarding matter of fixation of pay of Dr. Sudhir Kumar Goyal held on 23.10.2019 and resolved to fix pay as per rule.
- 17. Noted and approved the minutes of the committee formed by the Governing Body regarding matter of Provident Fund of Dr. Sudhir Kumar Goyal held on 23.10.2019.
- 18. Noted letter No. CS-III/149/STC/2019/Min./138 dated 18.12.2019 received from Assistant Registrar (Colleges) regarding the Hon'ble High Court of Delhi order dated 25.01.2017 and 14.03.2018 with regard to the promotion to the post of Senior Assistant in respect of Sh. Attaullah Khan.

As per EC Resolution No.230 dated 02.03.1994, period of validity of advertisement for appointments be extended from 15 months to 18 months.

In view of the above-mentioned rule, it was decided that fresh applications be invited for filling up of post of Senior Assistant through LDE as the validity of 18 months has been lapsed from the date of earlier advertisement. Hence, Mr. Attaullah Khan may submit fresh application for the post of Senior Assistant through LDE after taking vigilance clearance.

19. Noted letter from the National Commission for Backward Classes F. No. NCBC · 06/10/116/2019 regarding cancelling of appointment of Guest Teachers was discussed. As per the UGC letter No. F.25-1/2018 (PS/MISC.) dated 28th January, 2019, guest teachers are appointed on per lecture basis as interim measures to safeguard the interest of the students and are paid Rs. 1500 per lecture. The college sought

clarifications vide letter No. SC/ADMN. /PA-48/2019-20 dated December 16, 2019 and also reminder on January 2, 2020, but reply from the Hon'ble NCBC is still awaited. As per the DoPT rules on roster and reservation, the roster is not applicable in temporary and contractual posts which are less than for 45 days. Therefore, in the light of the existing UGC and DoPT rules the above order of the NCBC cannot be implemented.

Approved that on consequent joining of Dr. Nirmal Jindal, Associate Professor in Political Science department after availing Sabbatical Leave, Ms. Lamneivah Sitlhou, Assistant Professor in Political Science department on Ad-hoc basis has been relieved from the services of the college with effect from 09.01.2020
- 4. Approved the recommendation of Staff Quarter Allotment Committee that Dr. Avdhesh Kumar, Associate Professor, Department of Hindi has fulfilled the criteria for allotment of Type-IV Quarter No. 2 and Mr. Rajeev Kumar, Library Attendant has fulfilled the criteria for allotment of Type-1 Quarter No. 1. However, because the letter of Administrative Officer was also discussed in the committee and the recommendation was that, that if Governing Body approves then Ms. Sadhna Das could be shifted in Type-I, Quarter No. 1 and the type-III quarter, thus vacated by her could be offered to Administrative Officer who is the only eligible person to live in Type-III quarters. But the Governing Body was of the opinion that the service tenure of Ms. Sadhna Dash was left only for two and the half years, so she should not be asked to shift.

Subject: Regarding complaint of abrogation of reservation policy in guest lecturer appointment.

Consequent upon hearing held on 6th. 18th and 25th November, 2019 at NCBC office over the issue of violation of reservation policy in guest appointments, The Principal, Satyawati College is strictly directed to cancel all guest appointment made to various departments as per official corrigendum dated Oct 1 2019 and for which interviews were held between 14th and 24th October, 2019.

- 2. The same is further directed that all future guest appointments including appointments for next semester that begins from January 2019 are to be made by following reservation percentage wise for SC/ST/OBC as has been the regular practice in the Satyawati College prior to arbitrary corrigendum dated 1st October, 2019.
- 3. The Principal, Satyawati College is reminded that reservation is constitutional mandate and as such has been upheld by the Supreme Court Pronouncements. Any tinkering based on arbitrary individual judgment verbal or otherwise amounts to violation of Constitution of India and honorable National Commission for Backward Classes shall take appropriate action as mandated by NCBC Act 1993 and amended in 2018.
- 4. It is to be noted that non availability of roster cannot be the ground to deny the percentage wise reservation to SC/ST/OBC in public funded Central Government institutions as laid down by the Supreme Court of India in Indra Sawhney & others Vs Union of India case (1992). Moreover rosters are intended to be an aid to

determine number of vacancies reserved for SC/ST/OBC in any public employment so as to maintain required representations of these marginalized communities in public institutions.

- 5. It is to be noted that Department of Personnel and Training through official circular dated 15th May, 2018 categorically reiterates that in respect of appointments to Central Government posts and services, there shall be reservation for scheduled caste/ scheduled tribes/other backward classes in temporary appointments which are to last for 45 days or more.
- 6. This issues with the approval of Hon'ble Chairman, NCBC.
