Noted the letter diary no. 136 dated 28.01.2020 received from Mr. Raghunath Prasad Saket regarding the joining of two teachers on Ad-hoc basis in the department of Economics and a letter diary no. 137 dated 28.01.2020 received from Mr. Sujit Kumar regarding the joining on Ad-hoc basis in the department of Economics and decided to re-conduct the interview.
- 11. Approved the action taken by the Chairman, Governing Body on recommendation of duly constituted Selection Committee for the promotion of Mr. Sunil Kumar, Junior Assistant to the post of Assistant on the recommendation of duly constituted Selection Committee.

Note: As per the Seniority list of Junior Assistant of the college, Mr. Sunil Kumar, Junior Assistant was the senior-most employee who has completed 5 years of regular service as Junior Assistant and eligible for promotion to the post of Assistant. Departmental Promotion Committee (DPC) meeting was held on 4th February, 2020 in the principal's office for the promotion of Junior Assistant to the post of Assistant.

12. Noted the mail dated 4th February, 2020 at 3:10 P.M. received from Prof. Ram Lakhan Meena regarding final notice sent to him and disciplinary Proceedings against Dr. Ram Lakhan Meena, for not reporting to duty after the expiry of EOL.

Note: Dr. R. L. Meena against whom show cause notice was first served on 11th Oct., 2019 for not reporting to duty after the expiry of his leave on 13.08.2016 and despite being relieved from the University of Rajasthan on 10.08.2016 from the post of professor against which Dr. Meena was availing the EOL from the parent organization, i.e. Satyawati College, could not explain with valid reasons the second show cause notice with charges of willful acts of omission and commission resulting to derelictions of duty served on Dr. Meena on 22nd January, 2020. The GB in its meeting held on 10.02.2020 while taking note of the reply made on the letter of show cause notice did not see any merit in the explanations submitted by Dr. Meena and therefore, decided to terminate the services of Dr. R.L. Meena, Associate Professor, Department of Hindi with effect from 13.08.2013.

It further resolved to seek the concurrence of the Hon'ble Vice Chancellor, Univeristy of Delhi, the decision of the GB, Satyawati College to terminate Dr. R.L. Meena from the services of the College w.e.f. 3.08.2013 for remaining absent from duty without the authorization of the College Administration.
