- 1. The Governing Body of Satyawati College resolves to Regularise/ absorb services of Ad hoc Assistant Professors as was done under Temp Ordinance XIIIA (1977-78). The prolonged adhocism perpetuated in violation of the EC Resolution 2007 on the adhoc appointments. The number of adhocs has crossed above the statutory cap of ten percent as provided in the UGC Regulations 2010. These adhocs have been appointed following the statutory procedure. They have been making significant contribution to the academic and extra-academic life of the college in terms of teaching, invigilation and evaluation. But, they are devoid of any benefits like pay increments, maternity leave, medical benefits, etc.
- 2. It approved to extend the term of Dr. Manjula Dass as Officiating Principal for a period of six months or till post is filled on permanent basis, whichever is earlier w.e.f. 03.08.2018 as she is the senior most teacher of the College who fulfill minimum eligibility for the post of Principal as per 3rd and 4th Amendment of UGC.

- C (4) At all meetings of the Governing Body, one third of the members shall form a quorum.
- C (5) The Chairman of the Governing Body shall be elected by its members. In the absence of the elected Chairman at any meeting, the members shall elect a member as Chairman for the said meeting.

Please also see Point 3(3) of Ordinance XVIII "The Governing Body shall elect from among its own members a Chairman to hold office for one year provided that this does not exceed his current term as a member of the Governing Body, and shall be eligible for re-election."
