 - (b) There was no matter arising out of the minutes.
- 2. Approved to renew AMC of RO and award the same to M/s Santosh Electrical & Service Center who has given satisfactory service in previous year on same rate.
 - Note: The AMC of RO was awarded to M/s Santosh Electrical & Service Center on the basis of tender in which three Companies participated. The M/s Santosh Electrical & Service Center quoted lowest rate as compared to other companies i.e. Rs.2,03,000/The company successfully completed AMC of one year and is also ready to renew AMC at same cost. The College also took second opinion from M/s ION Exchange as most of the RO are of ION Company which quoted Rs.2,88,000/-
- 3. Approved to renew AMC of Water Cooler and award the same to M/s Santosh Electrical & Service Center who has given satisfactory service in previous year on same rate.
 - Note: The AMC of Water Cooler was awarded to M/s Santosh Electrical & Service Center on the basis of tender in which two Companies participated. The M/s Santosh Electrical & Service Center quoted lowest rate as compared to other companies i.e. Rs.66,000/-. The company successfully completed AMC of one year and is also ready to renew AMC at same cost.
