Subject: Advisory regarding mandatory 100% registration of all eligible youth aged 15-29 years on the MY Bharat Portal.

Respected,

The Government of India has launched the **MY Bharat (Mera Yuva Bharat)** portal as a unified national platform designed to engage, inspire, and empower the youth of our nation. The platform focuses on youth development through volunteering, leadership training, skill enhancement, nation-building projects, and various government-led developmental initiatives.

In compliance with the national directives, all educational institutions within the jurisdiction of North-West District are hereby advised to ensure **100% mandatory registration** of all eligible students and youth falling within the **15-29 years age group** on the MY Bharat Portal at the earliest.

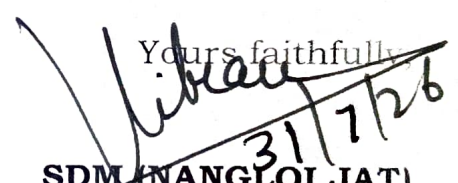
To achieve complete coverage, all Heads of Institutions are requested to undertake the following actions:

1. **Registration & Awareness Drives:** Organize dedicated registration drives, awareness workshops, and special help-desks within the campus to facilitate seamless on-the-spot registration for all eligible youth. Portal name for registration is **mybharat.gov.in**
2. **Correct District Selection:** While filling out the registration forms on the portal, students must be strictly advised to select their correct residential/institutional district (e.g., "**North West Delhi**" or as applicable) to ensure they receive relevant localized updates, district-level programs, and volunteering opportunities.
3. **Appoint Nodal Officer:** Designate a dedicated institutional nodal coordinator to handle technical queries, oversee the daily on boarding process, and coordinate with the sub-divisional monitoring team.

Furthermore, all institutions are required to compile and furnish their updated registration progress report to this office immediately upon completing their institutional drives, and continue updating it periodically until full compliance is met. The report must be submitted strictly in the standard format provided below:
